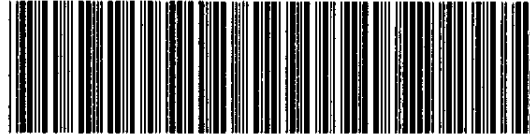

PARADIGM BREWING COMPANY, LLC**


