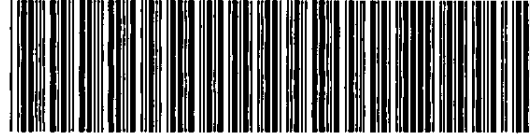

Article 5: Effective Date

The effective date shall be the date of filing.

Article 6: Other Provisions

- A. The limited liability company is organized exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), including for such purposes, but not limited to, establish a "pay-what-you-can" community cafe in concert with other such cafes across the country and throughout the world primarily to feed those in need, encourage those with means to be charitable, and to help eliminate hunger and reduce food waste in the local community; and the engaging in any other activity that is in furtherance of Section 501(c)(3) tax-exempt purposes.
- B. Upon the dissolution of the limited liability company, after paying or making provision for payment of all of its liabilities, the limited liability company shall dispose of all of its remaining assets to Leland Family Ministries, Inc. if said corporation shall at the time qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986. If Leland Family Ministries, Inc. does not qualify as an exempt organization at the time of dissolution, the assets shall be distributed to such organization or organizations organized and operated exclusively for charitable, religious, or educational purposes as shall at the time qualify as an organization exempt from Federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
- C. No substantial part of the activities of the limited liability company shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the limited liability company shall not participate in, or intervene in (including the publishing or

distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

- D.** No part of the net earnings of the limited liability company shall inure to the benefit of or be distributable to its managers, officers, or other private persons, except that the limited liability company shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in section A of this Article.
- E.** The limited liability company shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under § 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under § 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
