The name of the Limited Liability Company is ZHRAS TENT, LLC (the "Company").

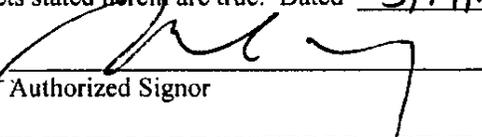

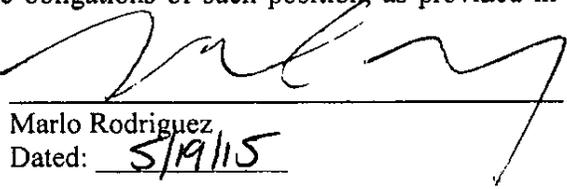
