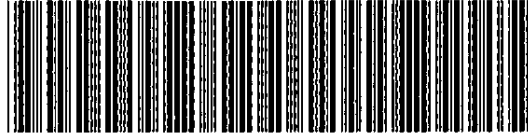

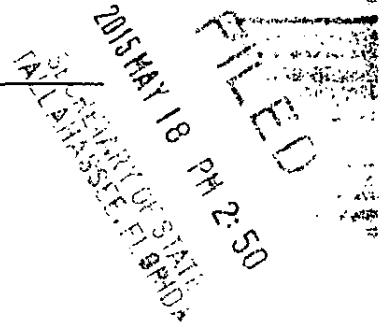

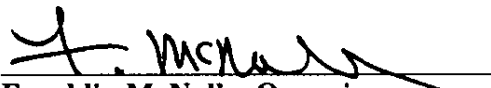
## ARTICLE VII
