The person that filed this and/or the person that submitted the application have done so without my knowledge or consent. My name is Tessa Chen from Kirkland, WA; I have no idea who Etisha Lewis is or have never contacted Corporation Service Company (Company Corporation) to file an LLC application with my name on it. I have never heard of Arion Forwarding LLC. They somehow obtained my credit card number and submitted the application using my credit card.

I contacted the company that charged my credit card (Company Corporation) on May 27th and they told me that they were an LLC forming company.
