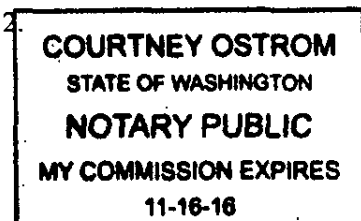
I would like to make you aware of a fraudulent submission of an Electronic Articles of Organization for Florida Limited Liability Company. Filed on May 21, 2015, number: **L15000090678**. The LLC is listed as: **Arion Forwarding LLC**, 5900 N Andrews Ave, Fort Lauderdale, FL 33309.


The person that filed this and/or the person that submitted the application have done so without my knowledge or consent. My name is Tessa Chen from Kirkland, WA; I have no idea who Etisha Lewis is or have never contacted Corporation Service Company (**Company Corporation**) to file an LLC application with my name on it. I have never heard of Arion Forwarding LLC. They somehow obtained my credit card number and submitted the application using my credit card.


I contacted the company that charged my credit card (**Company Corporation**) on May 27th and they told me that they were an LLC forming company. They notified me that they are not able to provide the information on the order; even though, they were the ones charging my credit card. I then filed a dispute thru my credit card company and thought nothing of it. Until I received a flier in the mail this past Friday to order checks for the business: **Arion Forwarding LLC**. That is when I did my own research and looked up the business under the State of Florida sunbiz.org site. There I found my name as listed person(s) under the LLC and as a Manager of the LLC.

I hope that you will take lengths to prosecute these people for a third degree felony for submitting false information to the Department of State as stated in s.817.155. These people should be brought to justice so they cannot continue their fraudulent activities.
