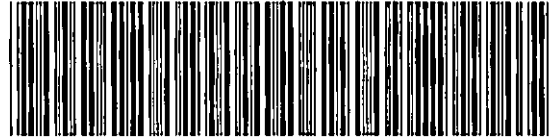

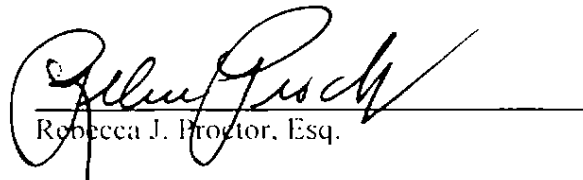

**ARTICLES OF DISSOLUTION

Pursuant to the provisions of the Florida Limited Liability Company Act, the undersigned Company adopts the following Articles of Dissolution for the purpose of dissolving the Company:

**ARTICLE I**
