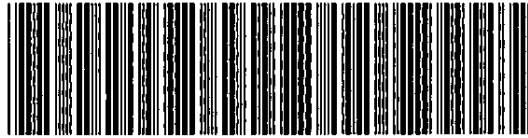

Name. The name of this Florida Limited Liability Company is **Rebecca Plager, LLC**.


