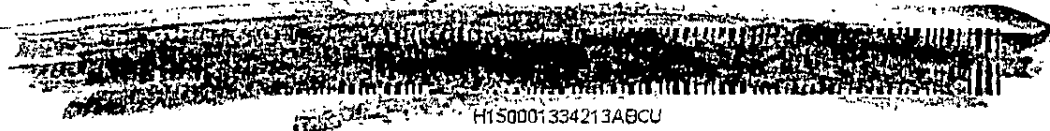

**RESTATEMENT OF
ARTICLES OF ORGANIZATION
OF

The Articles of Organization of Shore Lane of Boca Grande, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on May 28, 2015. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of the Company are hereby restated in their entirety to read as follows:

ARTICLE I - NAME

ARTICLE II - PRINCIPAL OFFICE


