

**RESTATEMENT OF
ARTICLES OF ORGANIZATION
OF

The Articles of Organization of CM Anslinger Capital, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on June 2, 2015. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby restated in their entirety to read as follows:

The mailing address and street address of the Company's principal office is 801 Via Lombardy, Winter Park, Florida 32789.


ARTICLE III - INITIAL REGISTERED AGENT

ARTICLE IV - MANAGEMENT


The Company is manager-managed. The initial manager of the Company is Christopher R. Male.
