**ARTICLES OF ORGANIZATION
OF
PENSACOLA SPRING STREET FESTIVAL, LLC**

The undersigned, SCOTT A. REMINGTON, a natural person competent to contract and an authorized representative of the members of PENSACOLA SPRING STREET FESTIVAL, LLC, hereby presents these Articles of Organization as the Articles of Organization of PENSACOLA SPRING STREET FESTIVAL, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is PENSACOLA SPRING STREET FESTIVAL, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 321 N. Devilliers Street, Suite 103, Pensacola, FL 32501. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSES AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - REGISTERED OFFICE AND AGENT

The address of the registered office of the Company is 125 W. Romana Street, Suite 800, Pensacola, FL 32502, and the name of the registered agent at that address is Scott A. Remington.


ARTICLE VI – MANAGEMENT


