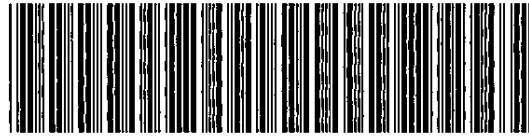

The limited liability company may engage in any activity or business in the practice of law permitted under the laws of the State of Florida.

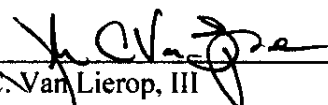

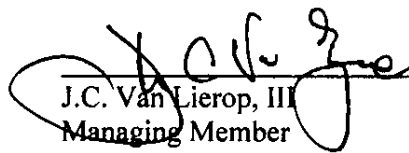
