ARTICLES OF ORGANIZATION OF AKUARIUS AI, LLC

THE AMERICAN STATE

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be AKUARIUS Ai, LLC, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 1925 SW 82nd Court, Miami Florida 33155 and the mailing address shall be the same.

ARTICLE 7 - ADMISSION OF NEW MEMBERS

A member may transfer his o her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no rights to participate in the management of the business and affairs of the Company or become a member unless all the others member(s) of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

These regulations may contain any provisions for the regulations and management of the affairs of the Company not inconsistent with law of these articles of Organization.
