

ARTICLES OF ORGANIZATION OF ALTA LAKES II, LLC



Pursuant to the provisions of Chapter 605 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, the following are the Articles of Organization for Alta Lakes II, LLC (the "Company"):
