AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF TEDELTA NORTH AMERICA, LLC

In accordance with Section 608.411 of the Florida Limited Liability Company Act, Fla. Stat. Chapter 608, the Articles of Organization of Tedelta North America, LLC, a Florida limited liability company (the "Company"), originally filed with the State of Florida Department of State on June 9, 2015, are hereby amended and restated in their entirety as follows:

ARTICLE I NAME OF LIMITED LIABILITY COMPANY

ARTICLE IV TRANSFERERABILITY OF MEMBERSHIP INTEREST

No members shall have the right to assign their membership interests in the Company without the written agreement of all of the membership interests, unless otherwise provided in the Company's Operating Agreement. If the assignment is not approved by all of the membership interests, the assignee shall have no right to become a member, to participate in the management of the Company, or to exercise any other rights or powers of a member. The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of

income, gain, loss deduction, credit or similar item to which the assignor was entitled, to the extent assigned.

ARTICLE V DISTRIBUTION OF PROFITS

Unless otherwise provided in the Company's Operating Agreement, there shall not be any distribution of profits unless each separate distribution is approved by the affirmative vote of members who own more than 50% of the voting interest in the Company. The voting members shall have complete discretion on when and if to approve any distribution of profits.
