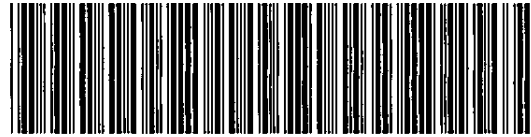



**LLC Name and Address**


