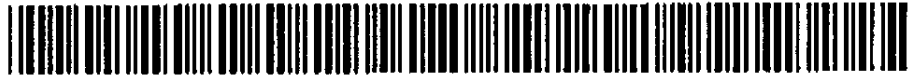

The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 605 of the Florida Statutes.

ARTICLE I - NAME

The name of this limited liability company shall be **KIDDER WATERSPORT RENTALS, LLC** (the "Company").

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

ARTICLE VII - MEMBERS' RIGHTS TO CONTINUE BUSINESS

The remaining Member(s) of the Company may continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company upon unanimous agreement and as provided in the Operating Agreement of the Company.

ARTICLE VIII - MANAGEMENT

The Company shall be managed by two (2) managers. The initial manager, who shall serve as manager until the first annual meeting of the Members of the Company or until their successors are duly elected, shall be Stephen J. Kidder. The name and address of such initial manager is as follows:

The Members of the Company shall adopt the Operating Agreement, which shall contain provisions for the management of the business and the regulation of the affairs



ARTICLE X - AMENDMENT


The Company shall have the power to amend or supplement these Articles of Organization when approved by unanimous vote of the Members.
