**ARTICLES OF ORGANIZATION  
OF  
JCCR REAL ESTATE HOLDINGS LLC**

The undersigned, for the purpose of forming a limited liability company under the Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I – NAME**

The name of the limited liability company shall be JCCR REAL ESTATE HOLDINGS LLC (the "Company").

**ARTICLE II -- ADDRESS**

The street address and mailing address of the Company is c/o Porter, Wright, Morris & Arthur LLP, 9132 Strada Place, Third Floor, Naples, Florida 34108.

**ARTICLE III – DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.

**ARTICLE IV – REGISTERED OFFICE AND AGENT**

**ARTICLE V – MANAGEMENT**

The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 
**ARTICLE VII – WRITTEN OPERATING AGREEMENT**


