ARTICLES OF ORGANIZATION

OF

BAYROCK NAPLES/MERCHANTS EXCHANGE, LLC

The undersigned person, acting as the authorized representative of BAYROCK NAPLES/MERCHANTS EXCHANGE, LLC, under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME
