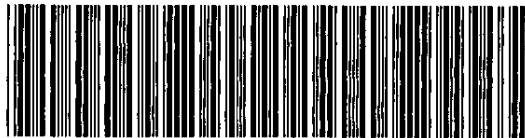



**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, adopts the following Articles of Organization:

**ARTICLE I**

Name
