ARTICLES OF ORGANIZATION OF RIECK SPINE AND JOINT CENTER, LLC

ARTICLE I Name and Duration

The name of this Limited Liability Company is RIECK SPINE AND JOINT CENTER, LLC, (hereinafter referred to as the "Company"). The duration of the Company shall be perpetual, commencing as of the date signed below or when accepted for filing by the Secretary of State.

ARTICLE II Principal Office

The mailing address and street address of the principal office of the Company is 20212 E. Pennsylvania Avenue, Dunellon, Florida 34432, or such other place as the Members may determine from time to time.

ARTICLE III Registered Office and Agent

The address of the registered office of the Company in the State of Florida is 20212 E. Pennsylvania Avenue, Dunellon, Florida 34432. The name of the registered agent at such address is Daniel E. Rieck.

ARTICLE IV Company Purposes, Powers and Rights

ARTICLE VI Amendment

The Members shall have the right to amend, alter, change or repeal any provision contained in these Articles of Organization, in the manner now or hereafter prescribed by a written agreement among the Members and all rights conferred upon Members herein are granted subject to this reservation.

ARTICLE VII Regulations

The power to adopt, alter, amend or repeal an Operating Agreement (Regulations) for the management of this Company shall be vested in the Members.

ARTICLE VIII Transferability of Members' Interest

A Member's interest in the Company may be transferred only with the unanimous written consent of all the remaining Members if the transferee intends to become a Member. Subject to the terms of a written agreement among the Members, without such consent, the transferee shall not be entitled to become a Member of the Company, but shall be entitled only to the share of profits, other compensation or return of contributions to which the transferror otherwise would be entitled.
