OF

The undersigned, pursuant to the provisions of Chapter 603 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

ARTICLE I. NAME OF LIMITED LIABILITY COMPANY

The name is: ACCELS 6, LLC, a Florida Limited Liability Company, (the "Limited Liability Company").

ARTICLE II. ADDRESS

These Articles of Organization have been executed on the date set forth under the name of the subscribing members.

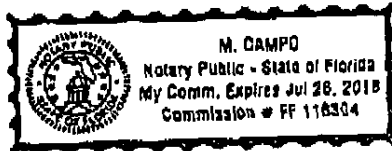

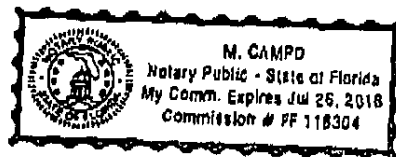
