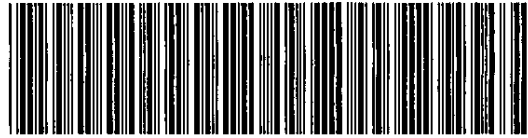

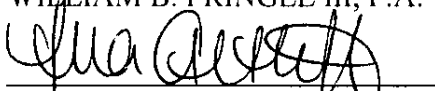

**ARTICLES OF ORGANIZATION

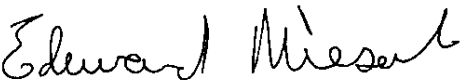
