Horton, a natural person competent to contract and a member of The Great Southern Pool Company, LLC, hereby presents these Articles of Organization as the Articles of Organization of The Great Southern Pool Company, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is The Great Southern Pool Company, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS




