
ARTICLE 8 - ADMISSION OF NEW MEMBERS

ARTICLE 9 - TERMINATION OF EXISTENCE



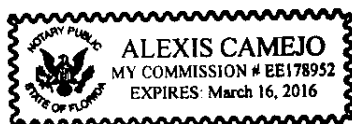


