ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a single-member limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I  
NAME AND ADDRESS

The name of the limited liability company shall be CIRCLE S RANCH HUNT CLUB, LLC ("Company"). The principal place of business of the Company in Florida shall be 11691 NE 150<sup>th</sup> Avenue Road, Ft. McCoy, FL 32134.

The Company shall be managed by a Manager, Managers and other named Officers in accordance with regulations adopted by the Member for the management of the



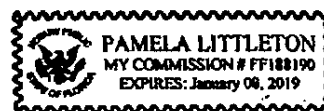


