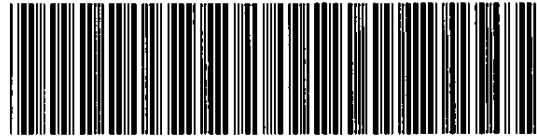

The Company's name is 301 Rome LLC. The Company is manager-managed.




