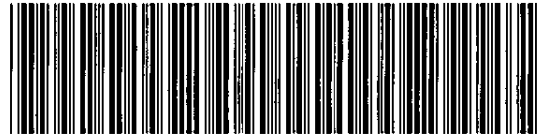

**ARTICLE I
Name**

The name of the Limited Liability Company is **ORANGE CARE IPA, LLC** (the "Company").

**ARTICLE II
Address**
