ARTICLES OF ORGANIZATION

OF

HODOR FARMS, LLC

AGREEMENT made as of the _______, day of ________, 2015, by HOWARD HODOR, ELLEN BERNSTEIN and KAREN MALTER, (hereinafter the Members or individually the Member);

NOW THEREFORE, it is mutually agreed as follows:

ARTICLE I

FORMATION OF LIMITED LIABILITY COMPANY
