
First: Article VII shall be and is hereby added to read as follows:

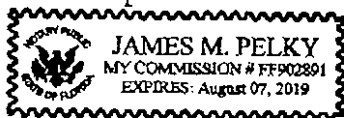
