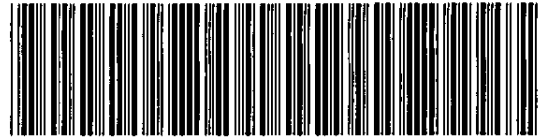

The Company is to be managed by its Managers. The person who will serve as Manager until the first annual meeting of Members or until her successor is elected and qualified is:

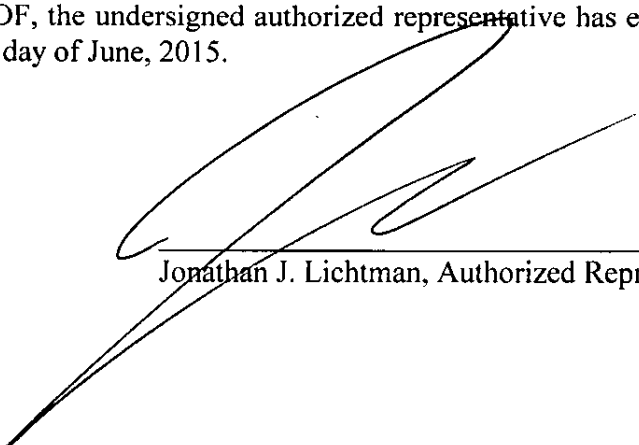
