ARTICLES OF ORGANIZATION OF KILO MANAGEMENT GROUP, LLC

The undersigned authorized representative of a member of a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Plorida Statutes, hereby submits the following Articles of Organization:

ARTICLE 1. NAME - The name of the limited liability company is Kilo Management Group, LLC (the "Company").

ARTICLE II. ADDRESS OF PRINCIPAL OFFICE & MAILING ADDRESS - The initial street address of the principal office and the mailing address of the Company shall be: 404 S. Willow Avenue, Unit 13, Tampa, Florida 33606.

ARTICLE V. DURATION - The period of the Company's duration shall commence on the date of filing of these Articles of Organization and shall exist perpetually unless terminated in accordance with the Company's operating agreement.

ARTICLE VI. PURPOSE - The purpose for which the Company has been formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.
