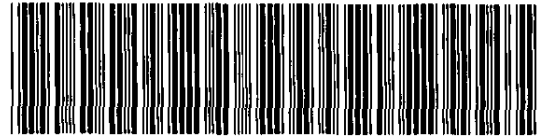



The name of this limited liability company (the "Company") is The Lodge at Ponte Vedra Beach, LLC.


ARTICLE IV - MANAGEMENT OF THE COMPANY


