ARTICLES OF ORGANIZATION OF
PADRON 6 FAMILY LLC

The undersigned, desiring to form a limited liability company under and pursuant to §605.0201, Florida Statutes, does hereby certify as follows:

- FIRST: The name of said limited liability company shall be Padron 6 Family LLC.
- SECOND: Padron 6 Family LLC shall exist in perpetuity.
- THIRD: Copies of the Operating Agreement of Padron 6 Family LLC may be obtained from the Manager at 9047 SW 117 Street, Miami, Florida 33176, which is the place in the State of Florida where the principal office of the limited liability company is located. The mailing address of Padron 6 Family LLC shall be 9047 SW 117 Street, Miami, Florida 33176.
- FOURTH: The purposes for which Padron 6 Family LLC is formed are:
- A. To engage in any and all aspects of investment management.
 - B. To trade, buy, lease, improve and sell real estate and personal property; to invest in stocks, bonds and any and all other securities and to participate in buying, selling and trading of the same; to invest in various business ventures and the purchasing and holding of the equity interests therein; and to loan, borrow or raise monies for any of the purposes of the limited liability company.


