The mailing address and street address of the principal office of the Company shall be 201 Alhambra Circle, Suite 1205, Coral Gables, Florida 33134.


ARTICLE III - REGISTERED OFFICE AND AGENT


ARTICLE IV - MANAGER-MANAGED
