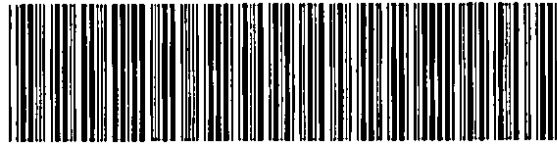

Plan of Dissolution

LASTINGER LEARNING VENTURES, LLC

PLAN OF DISSOLUTION

1. Lastinger Learning Ventures, LLC, a Florida limited liability company (the "Company"), shall be dissolved and liquidated effective as of DECEMBER 31, 2019.
2. Upon the adoption of this Plan of Dissolution by the members of the Company, an authorized person of the Company shall execute and file Articles of Dissolution with Florida Division of Corporations.
3. All debts, liabilities and obligations of the Company shall be paid and discharged, including, without limitation, the costs of providing notices of the dissolution to known claimants of the Company (if any) and unknown and contingent claimants of the Company pursuant to the Florida Revised Uniform Limited Liability Company Act (the "Act").
