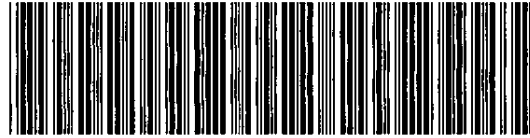

**ARTICLES OF ORGANIZATION**  
of  
**INTERSTATE DAWN PATROL LLC**

The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 605 of the Florida Statutes, as follows:

**ARTICLE I**

The name of this limited liability company is Interstate Dawn Patrol LLC (the "Company").

**ARTICLE II**

The mailing and street address of the principal place of business of the Company are 84 Country Club Road, Cocoa Beach, Florida 32931.

**ARTICLE III**


