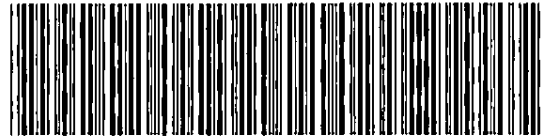

ARTICLES OF MERGER

OF

RED SKY SOLUTIONS, LLC
(a Utah limited liability company)

WITH AND INTO

PRESIDIO NETWORKED SOLUTIONS LLC
(a Florida limited liability company)

Pursuant to the provisions of Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Florida Act"), these Articles of Merger provide that:

FIRST: The name of the surviving limited liability company is "Presidio Networked Solutions LLC" (the "Surviving Company") and the name of the limited liability company being merged with and into the Surviving Company is "Red Sky Solutions, LLC" (the "Merging Company"). The state of formation of the Surviving Company is Florida and the state of formation of the Merging Company is Utah. The type of entity of each of the Surviving Company and the Merging Company is a limited liability company.

SECOND: The Agreement and Plan and Merger (the "Merger Agreement"), dated as of October 29, 2018, by and between the Merging Company and the Surviving Company, setting forth the terms and conditions of the merger of the Merging Company with and into the Surviving Company (the "Merger"), has been approved by the Merging Company in accordance with the requirements of Section 48-3a-1021 through 48-31-1026 of the Utah Revised Uniform Limited Liability Company Act. The Merger Agreement has been approved by the Surviving Company in accordance with the requirements of Sections 605.1021-605.1026 of the Florida Act.

THIRD: The name of the Surviving Company is Presidio Networked Solutions LLC.

FOURTH: The Articles of Organization and the Limited Liability Company Operating Agreement of the Surviving Company as in effect immediately prior to the effective time of the Merger shall be, from and after the effective time of the Merger, the Articles of Organization and the Limited Liability Company Operating Agreement, respectively, of the Surviving Company until thereafter duly amended in accordance with their respective terms and the Florida Act.

FIFTH: The executed Merger Agreement is on file at the principal place of business of the Surviving Company, located at c/o Presidio, Inc., One Penn Plaza, Suite 2832, New York, NY 10119.

SIXTH: A copy of the Merger Agreement will be furnished by the Surviving Company on request, without cost, to any member of any constituent company.

SEVENTH: The Surviving Company agrees that it may be served with process in the State of Utah in any action, suit or proceeding for the collection and enforcement of any debts,

obligations or other liabilities of the Merging Company and irrevocably appoints the Utah Division of Corporations & Commercial Code as its agent to accept service of process in any such action, suit or proceeding. The address to which a copy of such process shall be mailed to the Surviving Company by the Utah Division of Corporations & Commercial Code is c/o Presidio, Inc., One Penn Plaza, Suite 2832, New York, NY 10119.


EIGHTH: The Surviving Company agrees to pay any members of any limited liability company with appraisal rights the amount to which such members are entitled under the provisions of Sections 605.1006 and 605.1061-605.1072 of the Florida Act.

NINTH: The Merger shall become effective at 12:01 A.M. (Eastern Time) on November 5, 2018.


