**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
REALLY GOOD BEER STOP JAX BEACH, LLC**

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of Really Good Beer Stop Jax Beach, LLC, originally filed on July 1, 2015, are amended and restated in their entirety to read as follows:

**ARTICLE I - NAME**

The name of the limited liability company is Really Good Beer Stop Jax Beach, LLC (the "Company").

**ARTICLE II - ADDRESS**

The street and mailing address of the Company's principal office are:

**ARTICLE III - PURPOSE**

**ARTICLE VI- INDEMNIFICATION**
