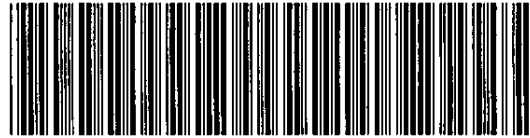



LLC Name and Address


