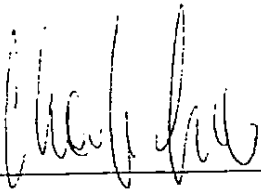


LETTER OF RESIGNATION & BUYOUT AGREEMENT

I, Charles R. Lee, hereby tender my resignation as manager/owner of Bullet Concepts Inc. effective June 9, 2017.

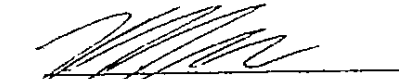
