**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
SYNERGY BIOLOGICS, LLC**

The undersigned hereby submits these Amended and Restated Articles of Organization ("*A/R Articles of Organization*") which amends and restates in the entirety those Articles of Organization filed July 6, 2015 ("*Original Articles of Organization*") of Synergy Biologics, LLC, a Florida limited liability company, and the same is submitted under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, to be made effective as of the date of filing.

**ARTICLE I - Name**

The name of the Florida limited liability company, formed effective as of July 6, 2015, pursuant to the filing of the Original Articles of Organization, is Synergy Biologics, LLC (the "*Company*").

**ARTICLE II - Address**

The mailing and street address of the Company is 1204 Miccosukee Road, Suite B, Tallahassee, FL 32308.

**ARTICLE III - Duration**

The period of duration for the Company shall be perpetual, unless dissolved by its membership or in accordance with the terms of an operating agreement, if any.

**ARTICLE IV - Management**

The Company shall be manager-managed. The name of the manager of the Company is David A. Hill and his address is 1204 Miccosukee Road, Suite B, Tallahassee, FL 32308. The Manager shall have all authority to direct the business and operations of the Company except as specifically delegated by the Manager to officers of the Company or other specifically designated individuals. 


