MEMBERS AND RESTRICTIONS

Members are classified in Member Class A and Members Class B.

Members Class A has capital contribution of eighty percent (80%).

Members Class B has capital contribution of twenty percent (20%).

Member Class A and Member Class B shall have the right to admit new

Class A and Class B members by unanimous consent. Contribution

required of new Class A and Class B members shall be determined

as of the time of admission to the limited liability company.

Class A member and Class B member's interest in the limited liability

company may not be sold or otherwise transferred except with the unanimous consent
