The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a professional limited liability company under the laws of the State of Florida.

**ARTICLE I
Name**

The name of the professional limited liability company is **Drill & Fill, PLLC**.

**ARTICLE II
Address and Place of Business**

**ARTICLE III
Period of Duration**

The professional limited liability company shall begin existence on the effective date stated in Article IX below, and shall continue into perpetuity, or until dissolved in a manner provided by law or by regulations adopted by the members of the professional limited liability company.

The effective date of these Articles of Organization is July 8, 2015.

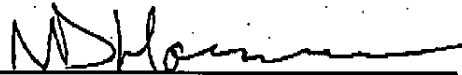
