The undersigned hereby certifies that he is the Authorized Representative of a Member who is forming a Professional Limited Liability Company under Chapters 605 and 621, Florida Statutes. The following Articles of Organization are hereby adopted.

ARTICLE I.
NAME

RIGHT TO ADMIT ADDITIONAL MEMBERS


