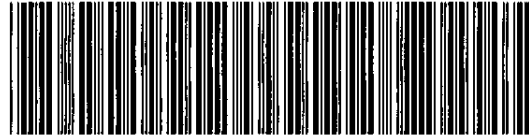

LLC Name and Address




