**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of amending the Articles of Organization of **HERITAGE WATERSIDE, LLC**, a limited liability company formed and existing under the laws of the State of Florida, adopts the following Articles of Amendment:

3. New Article VI is added to the Articles of Organization to read as follows:

ARTICLE VI
