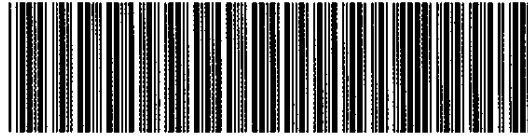

ARTICLE I

Name

The name of the limited liability company ("Company") is HADRIAN TECHNOLOGIES, LLC.

ARTICLE II

Address

ARTICLE III

Purpose

This limited liability company is organized to engage in the following purposes: to provide technology brokerage services which span multiple industries and verticals. The Company is designed to identify gaps in the corporate infrastructure and introduce proven technologies, products and business models and to engage in any and all lawful business for which companies may be organized under the laws of the State of Florida.


