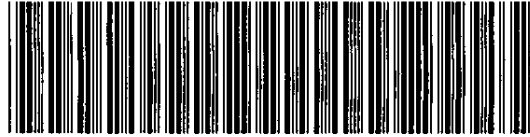

**ARTICLE I**

**NAME**

The name of the limited liability company is **410 FOREST HILL BOULEVARD, LLC**  
(the "Company").

**ARTICLE II**

**ADDRESS**

**ARTICLE III**

**PURPOSE AND POWERS**

Except as restricted these Articles of Organization, this limited liability company is organized for each and every legal and lawful purpose for which a limited liability company may be organized pursuant to the Florida Limited Liability Company Act, including to hold title to 410 Forest Hill Boulevard, West Palm Beach, FL 33045.


## **ARTICLE X**

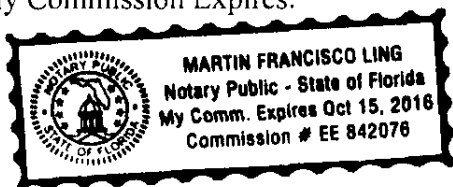
