**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION OF

First: The Articles of Organization of Global Veiculos II LLC were filed with the Florida Secretary of State on July 15, 2015 and assigned Document Number L1500011833.

Second: Such Articles of Organization (the "Articles") are hereby deleted in their entirety and Amended and Restated as follows:

MANAGEMENT**

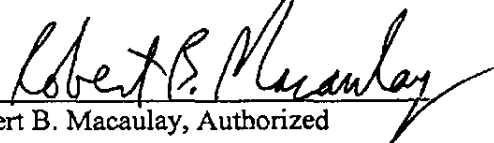
